EXPANSION SOUGHT FOR COMMUNITY MENTAL HEALTH SERVICES

The *Mental Health and Substance Abuse Plan for 2000-2003* released in April 2001 by the Department of Children and Families estimates that 7.9 percent of all children have a serious emotional disturbance and 6.3 percent of adults suffer with a serious mental illness. DCF estimates that our state mental health system is currently meeting approximately 33 percent of the treatment needs of children and youth and 15 percent of the treatment needs of adults.

To address this issue, HB 751 and SB 598 require that:

- DCF expand community mental health services with funds appropriated for FY 2001-02, FY 2002-03, and future years by implementing programs that emphasize crisis services and treatment, rehabilitation, support and case management.
- these appropriations are in a lump-sum category with a spending plan developed by DCF that includes a schedule for phasing in services and describes how the new services will be coordinated with current services.
- implementation of crisis services for children and adults who are experiencing an acute mental or emotional crisis occurs in the community mental health system by January 1, 2004
- implementation of mental health services for children and adults with mental illness occurs in the community mental health system by January 1, 2006.

The House bill further provides that in order to estimate the cost of this expansion, DCF, in collaboration with the Agency for Health Care Administration, shall develop and update annually estimates of the need for mental health services including forecasts of Baker Act expenditures, caseload estimates of adults with serious mental illness and children with serious emotional disturbance, the associated costs per person served and recommendations for maximizing the use of federal funds to meet these needs. The estimate is to be submitted to the Executive Office of the Governor, the President of the Senate and the Speaker of the House on August of each year. This bill was passed unanimously by both the House and Senate Health & Human Services Appropriations on Wednesday.

BILLS THAT MOVED THIS WEEK

SB 158 - Florida Infant Crib Safety Act (Commerce and Economic Opportunities; Wasserman Schultz) - This legislation prohibits commercial users from manufacturing, remanufacturing, retrofitting, selling, contracting to sell or resell, leasing, or subletting specified cribs determined to be unsafe for use by infants. It further prohibits transient public lodging establishments from offering or providing for use specified cribs determined to be unsafe for use by infants.

Last Action: 2/12/02 Favorable by Senate Judiciary; 9-0

SB 276 - Nursing Homes (Governmental Oversight and Productivity; Crist) - This bill revises the membership and terms of office of the Governor's Panel on Excellence in Long-Term Care and provides for the selection of the panel chairperson. It also provides conditions under which prohibition against payment of referral fees by assisted living facilities does not apply.

Last Action: 2/12/02 Favorable by Senate Judiciary; 9-0

SB 614 - Disabled Veterans/License Plate (Klein) - This bill authorizes certain veterans to apply for a license plate with a wheelchair symbol.

Last Action: 2/12/02 Senate Committee Substitute by Comprehensive Planning, Local and Military Affairs

SB 624 - Florida Golf License Plate (Silver) - This bill directs the Department of Highway Safety and Motor Vehicles to develop a Florida Golf license plate.

Last Action: 2/12/02 Committee Substitute by Senate Transportation; 8-0

SB 732 - Domestic Violence/Court Costs (Meek) - This bill provides for the assessment of an additional mandatory court cost of \$36 against persons pleading guilty or nolo contendere to, or those found guilty of, an act of domestic violence. Funds from this assessment are to be transferred to the Domestic Violence Trust Fund and used to provide legal assistance and legal clearinghouse services to victims of domestic violence served by domestic violence centers.

Last Action: 2/11/02 Favorable by Senate Criminal Justice; 7-0; Now in Children and Families

SB 968 - Healthy Kids Corporation/Operating Fund (Silver) - This bill allows Florida Healthy Kids Corporation to establish and manage an operating fund not to exceed twenty five percent of the Corporation's annualized expenses.

Last Action: 2/12/02 Favorable with 1 amendment by Senate Governmental Oversight and Productivity; 6-0

SB 1016 - Tobacco Settlement/ Proceeds (Burt) - This bill requires the Governor, in consultation with the Attorney General, to report to the Senate President, House Speaker, Comptroller, and Auditor General on the status of the tobacco lawsuit settlement agreement by October 1, 2002. The report must specifically describe and explain the settlement agreement's formula for determining the amount of the annual tobacco settlement payments and the application of the formula. The Comptroller must, in consultation with the Auditor General, verify the annual payment amounts and appropriately resolve inconsistencies. This verification process must be annually reviewed by the Auditor General, who must confirm that payments were properly made in accordance with the settlement agreement. Costs incurred from this oversight may be covered with tobacco funds.

Last Action: 2/12/02 Favorable by Senate Judiciary; 9-0

SB 1136 - License Plate/Protect Whales/Oceans (Pruitt) - This bill creates a Protect Florida Whales and Oceans license plate and provides for the distribution of annual use fees to the Harbor Branch Oceanographic Institution, Inc.

Last Action: 2/12/02 Senate CS by Transportation; 5-0

SB 1178 - Disabled Persons/Parking Permits (Wasserman Schultz) - This bill reduces the term of a temporary parking permit for a disabled person from 1 year to 6 months.

Last Action: 2/12/02 Committee Substitute by Transportation; 7-0

SB 1656 - Sexual Assault Counselors (Burt) - This bill provides for confidential communication between a sexual crime victim and a trained volunteer at a rape crisis center. It expands the privilege of refusal to disclose certain information to include communications between a victim and a trained volunteer. Additionally, it prohibits the disclosure of certain identifying information relating to sexual crime victims by public officers or employees.

Last Action: 2/12/02 Committee Substitute by Senate Judiciary; 9-0

SB 1808 - Florida Center for Nursing (Silver) - This bill authorizes the Board of Nursing to impose an additional \$5 fee upon nursing licenses and renewals to fund the Florida Center for Nursing. Provides for deposit of such fees in the Florida Center for Nursing Trust Fund. The Florida Center for Nursing was created by the Florida Center for Nursing in 2001 to address issues of supply and demand of nursing, including issues of recruitment, retention, and utilization of nurse workforce resources.

Last Action: 2/12/02 Committee Substitute by Senate Health, Aging and Long-Term Care; 11-0

HB 511 - Children/Continuances/Case Plans (Child & Family Security; Cusack) - This bill expands to all parties in child dependency court proceedings the ability to request a continuance due to the lack of material evidence, limits continuances to no more than 60 days per year and removes the required shelter placement reviews every 15 days.

Last Action: 2/12/02 Favorable by House Judicial Oversight 9-0

SB 592 - Adoption Assistance (Peaden) - This legislation provides authority for DCF to enter into interstate agreements with other participating states for medical and other necessary services for special-needs children. It also establishes procedures for interstate delivery of adoption assistance and related services and benefits.

Last Action: 2/13/02 Favorable by Senate Health and Human Services Appropriations 5-0; Now in Appropriations

HB 597 - Children's Medical Services/SPPEAC (Lerner) - This bill provides legislative intent regarding the licensure and regulation of facilities that provide care for medically fragile or technologically dependent children. It provides requirements for licensure of subacute pediatric prescribed extended alternative care centers (SPPEAC) and for licensee in administering and managing SPPEAC center.

Last Action: 2/13/02 Favorable with 1 amendment by House Health & Human Services Appropriations; 15-0

HB 629 - Office of Child Advocate (Lerner) - This bill transfers the guardian ad litem programs from the Office of the State Courts Administrator, providing for the creation of a statewide guardian ad litem office within the Justice Administrative Commission. The JAC will serve as the budget entity for the programs and provide administrative service and support. Additionally, the bill provides for reasonable fees to the guardian ad litem in certain situations.

Last Action: 2/12/02 Favorable with 3 amendments by House Child & Family Security; 7-0

HB 667 - School-related Events/Invocation (Council for Lifelong Learning; Holloway) - This bill authorizes individual district school boards by resolution to allow an invocation or benediction at specified secondary school-related events, effective 7/01/2002.

Last Action: 2/12/02 Passed the House 88-28

HB 755/SB 632 - Residential Group Care (Murman/ Peaden) - This bill prescribes procedures for the mandatory assessment of certain children for placement in licensed residential group care, specifies timeframes for initiating and for completing transition to community based care and expands authority for establishment of child welfare targeted case management projects.

Last Action: 2/13/02 Favorable by House Health & Human Services Appropriations 15-0 and Senate Health and Human Services Appropriations 4-1

HB 1569 - Nursing Homes/Staff Wages & Benefits (Argenziano) - This bill provides that the Agency for Health Care Administration must require that portion of a nursing home facility's Medicaid per diem payment is earmarked for an increase of \$1 per hour in wages or benefits for eligible staff members.

Last Action: 2/12/02 Favorable by House Elder & Long-Term Care 6-3

BILL PROPOSES DIRECT-SUPPORT ORGANIZATIONS FOR DEPARTMENTS

House Bill 1177 by Representative Gottlieb was approved by the House Child and Family Security Committee this week. This bill authorizes DCF and the Department of Elder Affairs to establish "direct-support organizations" as non-profit corporations to raise funds, receive grants, gifts and bequests, and make expenditures for the benefit of the Department's projects and programs. A direct-support organization is defined by

Florida law as a not-for-profit corporation to benefit or to provide assistance to a governmental entity. Universities and local school boards are among those governmental entities, which currently have direct support organizations. The bill provides for an annual audit of financial accounts by an independent CPA. The Senate companion bill, Senate Bill 1862 by Senator Wise, has not yet been scheduled for a hearing.

SHAKEN BABY SYNDROME PREVENTION BILL TO BE HEARD

Shaken Baby Syndrome is a term used to describe the effects of violently shaking the head of an infant or small child. This abuse can have devastating long term consequences including permanent brain damage, blindness, paralysis, or even death. Legislation, which would require hospitals that offer maternity and newborn services, to give to new parents informational brochures concerning the dangers of shaking babies and young children, will be heard by its first committees next week. The bill requires the Department of Health to prepare the brochures and prescribes their contents. It additionally provides that a cause of action does not accrue as a result of failure to provide this information. However, a hospital may be fined for

failing to provide this information if the hospital continues such a violation after it has been warned and given an opportunity to respond to the warning.

Senate Bill 1766, sponsored by Senator Sullivan, is on the agenda of the Senate Health, Aging and Long-Term Care Committee for February 19th. House Bill 1467, sponsored by Representative Waters, is expected to be heard before the House Child and Family Security Committee on February 21.
